SL thanked all for attending and dealt with housekeeping.

All introduced themselves.

2. Apologies for absence:

3. Appointments and resignations:

George Legg re-elected to post of Regional Rep (Western).

6. Matters arising from previous NC Minutes:

None.

7. <u>Campaigns/Priorities</u>:

The report opened with the news that MAG has made contact with the United Nations Environmental Programme to open a dialogue. There is an acceptance that PTWs "provide a short-term and immediate way to reduce emissions now" and this new relationship will be progressed.

One major issue that has been identified is that of 'dirty' fuel, a problem in Africa in particular. Analysis of diesel used there has shown that it contains up to 630x more sulphur that that used in Europe; and yet the fuel they are sent comes from Europe.

By working with the UN, there is the potential to move motorcycles from 'problem' to 'solution'.

Vision Zero – a multi-national road safety project that aims to achieve zero deaths and serious injuries on the roads now encompasses the promotion of 'active travel'.

ULEZ comes into force on 8th April with a charge of £12.50 per day for cars and motorcycles that do not comply with the emissions levels. A TfL impact study suggests that 4000 bikes will be affected. It has the potential to be the death of vintage vehicles generally and LÖ suspects that a legal challenge may be taken up.

Two potential courses of action were identified: sending TfL Certificates of Compliance (CoCs) and sending them the information that proves compliance.

SL noted that the Political Unit may well take a different approach as they need to be in dialogue with the relevant authorities.

In response to a question from DW, LÖ confirmed that, as yet, there is no information available such as a 'how to' flow chart.

A study has shown that particulate matter (PM) levels are 2,900% higher in the Underground than at ground level on a busy road. However, it has been stated that until there has been an impact study people should not be concerned!

The bike theft Roundtable has been shut down, ostensibly because it has achieved what it set out to do; however CB stated that none of the objectives had been achieved and he has not been invited onto the National Vehicle Crime Reduction Group. He will continue to attempt to get an in.

Following a question from TP, it was noted that it is early days in respect to working with the UN, but the goal is to establish a working relationship and link to the IMMA (international equivalent to the MCIA, who are not interested).

AC noted that if the motorcycle industry is not prepared to work to protect motorcycling, MAG could find itself taking the issues directly to the manufacturers.

8. Board meeting report (including FEMA):

All present apart from IC, who was attending FEMA AGM.

No appointments/resignations and no Skype meetings.

Minutes of previous meeting to be amended before being circulated for ratification.

JS is looking at improving the deal for electronic payments.

The finance report was circulated and discussed and AC requested some further details.

Reminder to submit expenses in a timely manner.

The self-service for memberships is being developed.

TC will continue to work on the website, including drafting in volunteers for support.

There has been no FEMA meeting since the previous TMAGL meeting.

Three applications for the post of Sub-editor for The Road were circulated and discussed. One has been identified for JS to progress.

It was noted that the title of Director of Public Relations used by IM in The Road conflicts with other titles/roles; IM to remove.

The Board will revisit the SWOT analysis and progress via email.

It was noted that memberships can no longer be circulated to Regional Reps due to recent GDPR regulations and that Reps should request appropriate information/assistance from Central Office.

The Board is to investigate instigating DBS checks for key personnel and look at submitting a new clause for the Constitution to take to the next AGC in respect to this being a requirement. It was noted that, as a volunteer organisation, MAG has a duty of care.

Discussion regarding the Political Unit.

AC noted that MAG used to produce a leather patch and requested permission to obtain a quote for new ones.

TP asked whether there is a link between lower membership numbers and the constraints of the GDPR on contacting members/lapsed members. SL stated that it is too soon to be able to judge this. Firstly apologies for missing Decembers NC but I fell asleep before! catching or rather not catching the Sleeper bad move, I blame an early start in Kracow, but at least I caught the Board meeting by Skype on the Friday and it gave me a couple of days to catch up on e-mails.

On 13th December went with Colin Brown, Andy Cameron, Glasgow Rep and Brendan Pollitt an Edinburgh member who had approached Glasgow Council about their proposed LEZ, to a meeting with Transport Scotland and Vince McInally from sustainable Glasgow at Buchanan House in Glasgow, only to find out that Stephen Tomson of Transport Scotland had screwed up his diary and the meeting was called off at the last minute. Thankfully Vince McInally saved the day and we had a very fruitful meeting with him in nearby Council Offices where we were able to enlighten him on many of the positive benefits of PTW use towards a nett reduction in emissions.

Meeting over it was time to head to Perth to meet Ian Garner from BEAR Scotland to review a study they had conducted on motorcycle accidents on the A92 in Northern Fife again a positive meeting with a chance to publicise Highways England positive approach to Motorcycling and a chance to investigate crash sites and details in the spring to try and determine measures which could be introduced to lessen the chance of re-occurrence.

17th January Re-arranged meeting/teleconference with Stephen Tomson of Transport Scotland an hour and a half's call with positive commitments on both sides to consider PTW's role in Scotland's four LEZ's. So we will be putting together Guidelines on Motorcycles for inclusion in Transport Scotland' LEZ guidelines document and a comparison of emission standards and emissions between cars and motorcycle and an undertaking by Transport Scotland to discuss with SEPA how they intend to consider treating motorcycles, ahead of a planned face to face meeting in March.

24th January attended and participated in a meeting of the Scottish Road Safety Framework Operational Partnership Group in Edinburgh, a fairly full on meeting with many issues discussed and some interesting submission including the piece on ISA from the German AA (ADAC) from the FIA conference on improving safety, circulated to the NC yesterday.

The meeting dragged on and I had to dash away before the close to attend a meeting of the snappily titled Wellbeing, empowerment, community and citizen engagement city policy committee to support and speak on behalf of a petition raised by Calum Moss to allow PTW's access to Glasgow Bus Lanes at Glasgow City Chambers, the presentation and question session went well, with a councillor on asking why PTW's had previously been excluded and being told they were for public transport only asked if that were the case why should PTW's be excluded given that cycles and private hire vehicles are permitted to use them. Another Councillor asked what else needed to be done to encourage the modal shift to PTW's given their environmental benefit over cars, we outlined some of the measures in Pathways for Progress and the positive result experienced by Northamptonshire Council. All in all positive and perhaps likely to be included in their 2020 Local Transport Strategy, though we will follow up with a full written brief to all Councillors and the Officer in Charge to try and ensure this happens.

25th January Responded to a consultation on the George Street New Town redevelopment in Edinburgh which threatens the loss of 28 Secure Parking Bays on George Street around 80 to 90% of the secure bays in the city.

27th January attended IAM Forum in Tillicoultry and gave a an update on MAG campaigns

7th Fe<mark>bruary .response raising an objection to a TRO threatening yet another central Edinburgh Bike bay.</mark>

In addition to the above working on the comparison between car and PTW emissions and emission standards for Transport Scotland also preparing a definitive report on the disastrous mini Orca trial on Aldgate High Street, Colin managed to get some answers to questions from City of London Council through an FOI request I am now trawling TfL's collision map and background data for details of collisions in the area pending presenting a full report to the OPG of the Scottish Road Safety Framework which will hopefully stop any spread of this scourge North of the Border in its tracks. Also need to finalise my piece on autonomous vehicles for the road.

Also attended Glasgow and Edinburgh Local MAG meetings and dealt with e-mails.

v. National Web Research Officer

vi. Network Officer

This time round this report will be a little longer than to say everything is going smoothly - February edition will be a little later than usual as I've been busy preparing all the paperwork for our Regional AGM which was held last Saturday.

vii. Executive Officer

Offices – No issues with in the office generally. We took delivery of the three MAG logo gazebos but we do not have much spare room to store these. One will be taken by GL region who will then store it and one will be given to Averill which will help. When time allows we will need to re-organise the stock room and hope that we can fit it in.

IT – No movement regarding the website as time has been limited. The group/region email lists have all been populated but now need the database to work alongside as lapsed members currently remain on the lists unless they unsubscribe form the original feeder lists. This has also become an issue regarding the 'Big' list, as they unsubscribe from the 'Big' list it does not unsubscribe that email address from the original feeder list which is a bit of a problem. I have spoken with Andrew M about this and we currently do have an issue if the 'unsubscribe' button is used, if they opt to reply to sender via email we can capture the original list where the address came from. To explain the 'Big' list collects email addresses from each of the group email lists, the activist list and the network list and this is repopulated every day at 00:01.

MAG Foundation – AGM set 9th February at Wren Hall. Some proposals have been forwarded and most have been approved. Finance report to be produced for the AGM.

Staff – The team areworking hard, Carol is as up to date as possible with regards to memberships and Campaigns really has more work to handle so have to be selective and realistic. Colin continues to work well and is making inroads regarding Vision Zero and has been asked to join the working group.

*** Lembit, Colin and I meet formerly on a bi-weekly basis and I am in contact as needed by each, this continues and works well the telephone conversations with the Chair currently remain weekly but will change to bi-weekly and as required shortly.

The Employee Handbook continues to be under review, so that it is maintained.

SMART Pension continues to work simply and easily.

Sub-Contractors contracts – No change. Sub-Editor applications with the Board for consideration.

My role – The new financial year is well under way and the next VAT returns are due shortly. I am currently looking at the costs for our merchant accounts and payment gateway and have had a meeting with Barclaycard. On the face of it do offer a cheaper option. I will now get Worldpay in to discuss and hope that they will match their competitor's costings. I am also looking at options for payments at events without signing in to a long contract or to have to pay the high short term costs. I have a few concerns about this access by possible 'unknowns' to us which needs discussing further. I have not

Finance Report


This is a brief report detailing any significant data which will allow you to see how we are financially for The Motorcycle Action Group Limited up to end of January 2019 (please note that these are draft figures until all standing orders/Bikesure figures are completed for the end of January).

The below graph shows that memberships by month have started off lower than the last three years, even with adjusting for standing orders and Bikesure figures this is lower than expected. Please note the graph includes up to the end of January 2019; these are not reconciled month end figures (as not all of

Bikesure figures are included due to the cool down period of 14 days up to 20.01.19). Bikesure memberships for 2018 overall have increased with a total of 920 compared to 2017 641, so an increase of 279 memberships. Of the 920 membership taken in 2018 242 were renewals. In line with the overall memberships taken in January 2019 the Bikesure figures are currently down so far with figures up to 20th January we have 17 new memberships compared to 45 in 2018 but renewals have increased 2019 total 10 against only 3 in 2018. This will be monitored and advised accordingly.



You will see from the cummulative figures that 2018 showed an overall increase in membership numbers in comparison to the previous years shown. So far this year, in total there has been a decrease of 89 memberships, hopefully this will level out in the coming months.





Please note that not all clubs use the associated nominated officers membership and prefer to pay, the database is showing 89 Nominated Officers.

12. Any other business:

i. Approve AGC 2018 Minutes

The Minutes had been made available on-list prior to the meeting.

ii. Discuss shortlist of potential Patrons

It was noted that this discussion is confidential and no names should be discussed outside this meeting.

AC outlined the actions that led up to this point: 23 names were submitted via the NC email list and a working group consisting of AC, JC, TS, AG and IM worked through the list independently to provide shortlists of seven in order of preference. AC collated this information into one shortlist: there were six clear favourites and a further four tied for seventh place. AC asked the members of the working group to list the four in order of preference and the one with most votes took the seventh place. These seven names were circulated to the NC list with a request for a list of five in order of preference. Four regions did not respond. One region stated that their preference was to have no Patron. Nine regions voted giving a final list of five in order of preference. It was noted that the NC has the power to appoint up to five or none.

AC stated that he felt that to appoint three would be appropriate.

RM stated that any appointments should be household names who are known outside of MAG.

AB suggested approaching the first person on the list only at this stage, so that MAG can learn from that experience to potentially improve the process for further approaches.

TP said there must be a clear idea of what we require from a Patron before they are approached.

AC said MAG needs to look at how a potential Patron sits in the media and what might constitute appropriate requests to the Patron (e.g. wearing branded clothing, attending events, an article in The Road).

To approach *** to see if they would be prepared to become a Patron of MAG.

Proposed: Alexander Bridgwood; Seconded: Richard Manton. Carried.

Working group to progress.

iii. Bikes in Buslanes, Yorkshire

Before opening this item, RM moved a vote of thanks for authorising a potential £1000 reward for information leading to prosecution in the case of a hit-and-run incident.

RM raised the issue of a lack of support from Leeds Council, following assurances that the Bikes in Buslanes initiative would continue. The West Yorkshire Combined Authority (WYCA) has discussed the issue in respect to its 20-year transport plan, but Leeds are against it despite coming under the umbrella of the WYCA.

The Political Unit noted that it may be counterproductive to release a PR just now (as suggested) prior to a meeting with them. However it was suggested that at that meeting the matter could be approached at a 'think there's been a bit of confusion' angle to see if there is any movement. If not, then a PR may be appropriate, to name and shame.

RM to liaise with CB/LÖ going forward.

13. Priorities:

SL advised that there has been a change to the process of identifying priorities for the Political Unit, with this now managed by Julie Sperling on a fortnightly basis. This has been working well so will continue.

This item will be listed as "Additions to Priorities" going forward.

AC noted that an update on MAG's work regarding the changed licencing regime would be helpful. LÖ to provide update.
