## **Motorcycle Action Group: National Committee Meeting**

Date: April 18, 2020 Time 12.00 pm Venue: Not applicable

### 1. Introduction:

Due to Government-led national restrictions on movement and social distancing in relation to the COVID-19 pandemic, the April 2020 NC meeting did not take place.

The Board of Directors met via Skype on the evening of Friday 17<sup>th</sup> April 2020 and the morning of Saturday 18<sup>th</sup> April 2020, and SL advised in advance that she would be available to speak to via phone/Skype, etc between 12.00 pm and 4.00 pm on Saturday for any questions from those on the National Committee.

## 2. Apologies for absence:

Not applicable.

Where Attendance Sheet is marked as 'Present', this indicates that persona have advised that they have viewed the Political Unit video report.

## 3. Appointments and resignations:

Dave Wigham re-elected to post of North East Regional Rep.

Tony Cox re-elected to post of North West Regional Rep.

In recognition of the fact that AGMs can no longer take place until restrictions are lifted, a proposal will be taken to the NC list to propose that the Constitutional requirement for all AGMs to take place no more than 15 months following the last one be suspended until further notice.

#### 4. Adoption of NC agenda:

Not applicable.

### 5. Ratification of previous NC Minutes:

i. Minutes of previous NC meeting.

To accept the February 2020 NC Minutes.

Proposed: George Legg; Seconded: Steve Wykes. Carried. Vote taken via email.

ii. Minute of any email votes taken between NC meetings.

To accept the recently generated Position Statement regarding Vehicle Excise Duty.

Approved with minor amends.

## 6. Matters arising from previous NC Minutes:

SL: Provide Ride2Work Day flyers to April NC meeting. Unable to action: no physical meeting.

AC - Circulate social media stats to NC list. Done and exercise repeated with figures appearing in the Vice Chair report to NC.

## 7. <u>Campaigns/Priorities</u>:

CB and LÖ, with support from SL, put together a video report, which has been circulated to the NC.

NC requested to view and confirm via email that they have done so. This confirmation to be taken as "attendance" and recorded on the Attendance Sheet.

See Appendices for attached formal reports.

### 8. Board meeting report (including FEMA):

The Board met via Skype on Friday evening, including Julie (JS), and again on Saturday morning with the Political team. The Board has been in regular contact via email between meetings. The Board, along with JS, has worked to observe the Government restrictions currently in place and to ensure the organisation does not run into financial difficulties.

There were some technical difficulties in getting everyone on Skype. IM was invited to both meetings but did not attend either of them.

No appointments or resignations.

Minutes of previous meeting approved and action points from previous meeting addressed. No Skype meetings held between scheduled Board meetings.

Executive officer report received by email: Charley Davies (CD), Sub Editor, was contacted regarding his role as it was felt this was an area where savings could be made. CD was asked whether, in the current circumstances, he would be prepared to work as a volunteer. His response was 'lay me off and come back to me when things change'. Following discussion and bearing in mind CD contract has reached a review point, the Board agreed that the contract be terminated and subsequently reviewed when MAG is again in a position to pay for such additional services.

Finance report: JS received an email from Warwick Council and is applying for 'small business rate relief' and has also applied for and had approved a non-repayable Government Grant in the amount of £10,000. The frequency of finance reports has been increased to monthly. Alarm points have been set for when reserves fall to 4 months, 3 months, 2 months and 1 month (current reserves 6 months). SL to remind RRs that funds should continue to come in as revenue stream is extremely important at this time.

IT/Website: JS has not heard from Leslie regarding the database; she will continue to try to make contact. Progress continues with the website although it has been delayed, in part due to the current situation. JS is confident there will be a working version available in May for 'release' in June.

FEMA: IC attended the FEMA AGM last time the NC met and had a Microsoft Teams meeting with them on Thursday evening. Everyone is in a similar situation throughout Europe regarding Coronavirus. The situation regarding illegal riders and how they make up rider statistics, first raised by SMC, Sweden, is something other countries may take on; see IC article in The ROAD issue 87, page 48 & 49. Regarding a joint MAG/BMF statement following Brexit, there is an agreement that this will happen towards the end of the year.

MAG's next FEMA membership payment is due in June (payments are made quarterly). Suggestion that we consider requesting a payment holiday, with a decision to review nearer to the payment date.

MAG Media: The current situation and cancellation of events led to last-minute changes and space needing to be filled in the magazine. IM managed to fill all the pages and get the pages to the printers on time. The printed magazine has arrived at the office and has been despatched to members. A quote has been obtained so we can make informed decisions going forward. See A.O.B. The next issue of The ROAD should go out on time, perhaps with a few less pages if there is concern over content; SL to communicate this to IM.

NEL: Following the introduction of lockdown, the office-based staff were offered the option to work 4 days a week with no loss of pay in consideration of their personal circumstances and in order to adjust to the changes. Following this meeting staff are to return to 5 full days a week, subject to workload.

## Overview of where we currently are:

CB and LÖ continue to work from home (which is usual practice) and Julie and Carol are also still working. MAG currently has 6 months financial reserves. Call-out to NC for surplus funds to be donated to central will be circulated. Some members not attending ITV are, in effect, donating by not requesting a refund of their ticket money. Cash is coming in via the donate button on the website, including some quite sizeable donations, and one person has set up a monthly payment.

Furlough: Only available if staff are not working at all, which is not the case with our staff. We still have funds to continue to pay all staff costs. Furlough is not an option at this time.

Reducing running costs: There is little scope to reduce running costs as we already run a very efficient operation. JS will continue to seek Board input on whether to pay in full, part-pay or defer on individual invoices. We do not hold large amounts of stock, nor have we plans to increase our stock.

Virtual meetings: This meeting has had technical issues with 6 people, so to get the whole NC online at one time would be impractical and unmanageable regardless of the program used. The meeting could potentially be broken into smaller groups, a consideration for the June meeting.

Figures on membership and plans to 'scoop up' any missed renewals: Identify where a cancelled event may be a recruitment opportunity. Encourage members to add/update their email address in the database, so we can make the best use of electronic communication. Draft a PR to tell people we are missing the cancelled event and seeing them, and to ask them to check the expiry date on their membership card. Repeat message through Network and The ROAD that people need to check and renew, that MAG is still operating, that their membership is important to us, and including options to make a donation.

Look to take on an IT Undergraduate (IM suggestion): Educational facilities are shut at this time. This would be a long-term plan and if we were to go down this route and involves investment in terms of money and time. Not something to consider further at present.

Change Lembit's role to purely recruitment (IM suggestion): Not practical in the short term.

Suggestions presented to IM:

Form a committee or website to post ideas on about how to fund MAG this year without the events. Response: We already have a committee in the NC, and they will be consulting with their members. Double the frequency of The ROAD and charge £2 for it.

Response: Not feasible.

Pay our 2021 membership subscriptions now and have automatic renewal at the end of this year. Response: Logistically possible but would have implications for next year in respect to maintaining a regular income.

Offer a new three-year membership, discounted to £60 (for example), to be taken out now. Response: Logistically possible but would have implications for next year in respect to maintaining a regular income.

£10 donation from each member.

Response: a donate button has already been set up on the website.

Offer to clean somebody else's bike or car for a contribution to MAG?

Response: none required, although AC noted the impracticality of this in lockdown.

AGC 2020: Whilst we do not yet know what, if any, restrictions will be in place at the end of September, SL feels it is highly unlikely that AGC 2020 will go ahead as currently scheduled. No region has yet submitted a proposal to host, and once meeting restrictions are lifted it is likely to be too late to book a venue given that all venues have had events pushed back. JS advised that Pete Walker has said there may be a way for Yorkshire to host. SL will investigate. AC pointed out that, even if there are no restrictions, some people will not be prepared to attend large indoor gatherings for a long time. Investigate options (including suspension) and discuss with NC.

Press release regarding Oxford County Council Transport policy release and biased position statement on motorcycling on Friday 17<sup>th;</sup> TRF supportive.

PR on VED position.

Still working on possible CBT extension (to be followed by a PR). Government may take the view that they still want the revenue. MCIA have contacted Government on this issue; MAG needs to follow up.

ABS: Jon Strong involved in drive to press for standardisation to reduce costs and ensure this safety critical equipment is adequately maintained and not avoided on cost grounds.

ChiPT: work currently digital so can hit the ground running when Coronavirus emergency is over. Next meeting in two weeks' time and potential sponsors to be approached at that stage.

Ride2Work publicity continuing.

No further contact with British Cycling at this stage. Possibly look to them for support regarding our position on VED.

TP helping with nationwide FOI request regarding bus lanes and motorcycle access.

Cambridge awaits public consultation.

Secure parking: Bike theft continues with high levels of inaccuracies on vehicle descriptions. Improvement in data reporting required. Need to pursue survey of Police figures.

MCIA: Nothing to report.

Putting data together on modal shift, hybrid worse than ICE and electric vehicles. Northamptonshire positive; putting figures together on effect of discouraging motorcyclists regarding Carbon shift created by using cars.

Vision Zero: totally contradictory findings. Heidi Alexander rejected claim that motorcycle accidents have been exacerbated by cycle schemes.

Push Government to update motorcycle policy. Grant Shapps tied up with Coronavirus, so will make approach via Junior Minister for Transport, Kelly Tolhurst.

Activities in the period were as follows and most seem an age ago now.

February 7th - Attended Board meeting at MAG Central

February 8th - Attended NC Meeting at Honiley Court Hotel, Honiley, Warwickshire.

February 21st - Submitted Transport Scotland Low Emission Zone - Guidance and Regulation Consultation (Copy attached).

March 1st - Attended NE MAG AGM in Durham as NC observer, despite limited turnout the meeting followed procedure and all sitting committee members were duly proposed, seconded and elected. Welcome back Dave.

March 6th to 8th - Helped set up and man MAG Stand at the Scottish Bike show at Ingliston near Edinburgh, many thanks to Avril and Kaye for bring the stand up from the North East and lugging it back down again on Sunday.

Over the course of the weekend as well as talking to many members we signed up approximately a dozen members of which two to three were new, with the remainder being renewals. The opportunity was also taken to highlight the Edinburgh City Mobility plan consultation, which strangely does not recognise motorcycling as part of the solution. Apparently, we are all supposed to Walk Cycle or use public transport for all journeys regardless how impractical this may be.

Other stuff attended Edinburgh and Glasgow group meetings in February and March. Finalising response to Edinburgh City Mobility plan consultation to be submitted by April 30th.

### South East: Steve Mallett

1/ Attended Feb NC and various N Kent branch Meetings.

2/ Thurs 13/3/20 with Dep Rep JC Quinton, delivered GL MAG stand to the ExCel MCN London Bike Show and set-up on site. Members of N Kent MAG manned the stand on the Friday + 1 on Sunday signing up approx 12 new members.

3/ Lower Thames Crossing, the latest supplementary report is out. After careful dissection of the report and attending public consultations the following progress has been made.

The Crossing and adjacent connections will be to 'All-purpose Trunk Road status' (GD 300) and as such will be 'green sign-posted'.

The same charges as the Dartford Crossing will apply = no charge for m/cs.

NB, the current Dartford charge is technically not a toll but a congestion charge.

\*Funds to build the LTC have now been allocated in the latest budget, 11/3/20.

Exclusions in the LTC, although not a motorway, the same restrictions as to use will apply, therefore no learners on 125cc bikes.

Local MAG members have attended 4 of the local public consultations and put MAG's concerns to the duty staff. At all these consultations the staff were helpful but very ill-informed. One staff member telling me that motorcycles of 500 cc were not allowed on motorways....!

#### 4/ M20/smart motorways.

Following pressure from SE MAG's JC Quinton, Local MP Tracey Crouch has questioned the transport Minister in Parliament and consequently halted the implementation of Smart Motorway status on a section of the M20. There is no safety radar in situ and the emergency refuges are too far apart. Until this is sorted out, a 50-mph restriction will remain in place.

Following a FOI request to Sussex Police for information, Rep Andy Cutts has met with his new MP (Sally-Ann Hart) to discuss bike theft in Sussex. (await report)

a/ Fred Hill ride, 1/3/20, 5 x members rode to London and joined up with the GL ride to Pentonville, Sadly, numbers were well down with just 12 persons in total attending.

b/ 8/03/20,'C' road Ride -out with affiliated clubs, (VMCC, BSAoc, REoc members)

c/ Quiz night with affiliated Honda OC, on hold/ cancelled.

In the spirit of Mr M's last Editorial, we continue to reach out to affiliated clubs.

d/ Rock Night 21-3-20 was cancelled.

e/ Fund raising Virtual rally, will be on N Kent MAG fb, 'Into the Garden', being organised for Fri 24th April at 6pm.

#### 7/ E Kent

Kalona and Sue from E Kent HAD started their bike nights again based on Pebbles Beach Kiosk. In spite of rain and gales they got a good turnout, (Now cancelled until further notice)

8/ 31/3/20: Transport for South East Forum, attended via 'Zoom' link. Meeting mainly focused on the feedback from their public consultations. There was a 'Top Ten' of subjects raised and, sad to say, motorcycles were not represented. There were several training sessions planned to coincide with our meetings this weekend, none of which will happen now. It is best we all stay home and stay safe.

As I have said on list, "I am available on Saturday to take any questions". In the meantime, your reports need to be submitted; I know many of you have done so, and when it is released watch the Political teams report and confirm you have seen it for registering your attendance.

As already advised and here for the purpose of the minutes: The NC will not have a full virtual meeting as the broadband my end is not up to it. A.O.B. on email to me directly or contact me via any means you use.

### Vice Chair:

I attended the Board and NC meetings in what now feels like an eternity ago but was only February. My regular MAG article in South East Biker has moved from print to being online during the crisis, so MAG news is getting out there albeit in a format that cannot be used if there is another loo roll shortage. I have been monitoring the MAG Facebook page and whilst we have not had a lot of questions, from March 19th to April 15th page likes are up 323%, our "reach" is up 765% (that's the number of unique people who saw a post) and post engagements up 627% (likes, comments, feedback, etc) which I assume is as a result of people being at home. I have no data to back this up, but I have noticed a lot or groups, clubs, and online organisations start to follow MAG, which further increases our reach.

I have been talking to Selina on the phone and via email in respect to the on-going situation, as well as engaging in Board, NC and PR team emails. I have also been in touch with Pete Walker to discuss the impact of the lockdown on MAP who are looking at their options in respect to cancellations, postponements and re-scheduling of events.

We have received a few enquiries as to what is happening in respect to those riders that wish to renew their CBT (some riders don't bother taking their test and renew their CBT every 2 years). I have been in touch with a contact at the DVSA and Colin has been talking to the MCIA. My personal view is that there should be an extension to the 2 years as not all test centres are open.

#### vi. Executive Officer

Offices – Plans were set in place as we entered the Covid-19 crisis regarding the opening/running of the office, these were quickly changed on the evening of Monday 23<sup>rd</sup> March to a lockdown. To be honest it did catch us out as we had not expected the lockdown to occur as it did. Over that week and the following weekend, a VPN was sorted so that I could work from home with full access to the office server and my work pc. This incurred an additional charge as my personal laptop's operating memory was insufficient and caused some issues at the beginning. Carol's workload had decreased slightly and I agreed for her to cover the office Monday, Wednesday and Friday, this has now changed due to Mr M's article in MCN we have had around 30 new members of which 26 were related to that article and one of the clubs is looking to sign up 20 of their members with full memberships, so the office has been busier than expected. So Carol has been in everyday and taking calls and is quite busy. On quieter days the office will close after the post is collected at around 4.

IT – Website research is progressing, and a conference call is being arranged to go onto the next step. It is slowly progressing, and the plan is still on target for a May/June launch in line with the Ride2Work Campaign. The front page has to be right to get visitors to turn into members by joining, we get this right and our membership will grow.

The Database has not progressed further, I am waiting for a response from Leslie and will update accordingly.

Social Media training for Reps delayed due to Covid-19 this will be re-booked as soon as possible.

MAG Foundation - Nothing to report at this stage.

**Staff** – Carol is working hard ensuring that memberships are up to date. We have a daily chat and communicate as required in addition to this. Her loyalty to MAG is brilliant and cannot be questioned. Colin continues to work to a high standard and finding barriers as officers are not responding to his emails which he is finding frustrating. Planned updates with Mayors and Police Commissioners elections have been delayed for a year, to allow COVID-19 to pass and allow the country to return to normal. Lembit had made progress with the Government Motorcycle Policy update but that has now been delayed as everything else has. Lembit has taken E10 consultation into his priorities which works well with CHIPT project. \*\*\*

Staff appraisals have been completed. \*\*\* All wish to thank the Board for their generosity in giving pay increments.

The Employee Handbook continues to be under review, there are many changes with the outbreak of COVID-19 and April will see many changes come into effect that will require updating.

**Sub-Contractors contracts** – Mr M has been more pro-active in getting copy for the latest issue of The ROAD. Issue 87 was much improved with the longer proof period. No concerns with Charley regarding his standard of work. \*\*\*

My role – No change in real terms now working from home and visiting the office once a week to collect post, files etc. My laptop caused a frustrating time (at the beginning) as it required a small upgrade to allow me to work via a VPN. The main addition to my workload is weekly cash-flow reporting with warnings to the Board at set points regarding reserves and the use of our reserves to maintain stability. We are in a good position to ride this crisis and in real terms carry on as near normal as possible. We are however keeping all spending to essential only, so in real terms ensuring members get the service that they pay for, externally no difference will be seen. We are preparing should we need to reduce costs further should this crisis last for a longer period than expected. I am in contact with the office and available to the Campaigns team as required. Due to my asthma I am keeping all face to face none household contact to zero, my daughters are doing my food shopping (which is costing me more than normal!) my only freedom is my horse and the yard is keeping to allotted times to keep distance rulings for all liveries, I am lucky as I am in a barn with my daughter so do not see others.


## vii. Finance and membership figures



### **Clean Air Zones**

Coronavirus has seen a raft of delays to the implementation of various Clean Air Zones, including Birmingham, Leeds and indeed to the Oxford Zero Emission Zone.

Whilst the initial report following the Oxford ZEZ accepted none of our points, there was a second consultation launched on minor changes. With the lockdown there was an announcement that the consultation would be suspended until the summer. Prior to this I had contacted relevant officers to arrange a conference call, but this had not happened by the time of the postponement.

I submitted a full written response to the Welsh Clean Air Plan following my attendance at the stakeholder workshop in Aberystwyth.

### Crime/Secure Parking

FOI responses are coming in for the Police Force Bike Theft Rankings. The timescale pressure has been taken off due to delay of Mayoral and PCC elections, but we will publish as soon as possible. \*\*\*

Hackney Parking Consultation has drawn reaction from the MCIA who have asked about possible joint position. I have yet to explore this with them. I have reached out to Cllr Jon Burke, Cabinet Member for Energy, Waste, Transport & Public Realm, but received no response.

### **Road Safety**

Very little to report with the RSGB conference postponed till September.

Attended a LRSC/TfL data session in February. The need to challenge TfL on its performance when it comes to motorcycle safety is growing with motorcycle fatalities increasing while cycle fatalities decline.

### **ULEZ Campaign**

ULEZ and the Congestion Charge have both been suspended during the lockdown.

#### **Bus Lanes**

Excellent result progressing in Cambridge where a policy of motorcycle access to bus lanes is being progressed as a climate change policy. We have been invited to respond to a stakeholder survey initially. A public consultation will follow but timings are yet to be announced.

Oxford rejected the bus lane access solution to reduce the rat-run nature of delivery rider access through their Zero Emission Zone.

### **Transport Policy**

Full written response submitted to Birmingham Transport Plan following meeting with Cllr Zaffar and senior officer. It appeared that the key message was accepted – i.e. they have forgotten to consider motorcycles. Consultation period has been extended

## Ride2Work Day

Filming of the Filter Friendly video has been compromised by the lockdown. It is highly unlikely that we will be able to get the video launched for this year. I am determined that RTW Day campaign will run as an awareness/comms campaign. Clearly there can be no work "in the field" but as an online awareness campaign there is no barrier to continuing. Website is well under way.
