The Board of Directors met via Skype meetings on the evening of Friday 12<sup>th</sup> June 2020 and on the morning of Saturday 13<sup>th</sup> June 2020.

# 6. Matters arising from previous NC Minutes:

None.

### 7. Campaigns/Priorities:

CB and LÖ provided a video report, which has been circulated to the NC.

LÖ highlighted a potential legal challenge against Sadiq Khan regarding the reintroduction of the Congestion and ULEZ charges. The premise of this challenge is that it goes against the Government's exhortation to avoid public transport, if possible, during the Covid-19 pandemic.

A brief discussion around this matter concluded that MAG cannot get involved financially with this crowd-funded challenge but would be in a position to provide some promotional involvement.

Parking and roads access are both issues that have been raised, and SW asked whether pressure could be brought to bear on the Government to take its approach of promoting cycling and extend it to motorcycling. CB stated that this is something that is being done, with encouragement to provide dual-use space, which would be a low-cost provision.

LÖ noted that MAG is, nowadays, respected at an unprecedented level.

SL advised that production of the original Filter Friendly video had to be abandoned due to lockdown restrictions, but that Colin had been able to put one together with the assistance of Julie and her family and Northants Police. This is now available as part of promoting Ride To Work Day.

TF passed on thanks from London's social media group to CB and LÖ for work done during lockdown.

LÖ advised that the ICE ban is our biggest threat and encouraged submissions to the formal Consultation, which closes on 31/07/20. A discussion ensued regarding the ICE, alternative fuel sources (e.g. E10, hydrogen-based, etc) and tax exemptions.

It was further noted that electric vehicles are currently exempt from road tax but that this will almost certainly change as they become the 'norm'. CB stated that revenue streams will be affected and that the weight-based system being promoted by MAG would be an easy way to address this.

TC advised that there is much research and development going on with large commercial engines in relation to running green fuels (such as bio CNG/LPG). There's also work on synthetic fuels aimed at smaller engines such as those used in MotoGP and Formula 1. This could lead to alternative fuels being available for personal vehicles. He also expressed concerns that we seem to be putting a great deal of effort into matters that are not entirely motorcycle related.

Discussion ensued around ICE in general - and motorcycles in particular - and LÖ will continue with work in relation to ChiPT as per the direction of the NC at February meeting. He emphasised that we need to work with other organisations where possible to maximise our influence.

SL noted that there are still funds available to provide memberships to MPs. JS to provide a 'script' regarding the offer.

#### 8. Board meeting report (including FEMA):

The Board met via Skype on Friday evening, including Julie (JS), and again on Saturday morning with the Political team.

No appointments or resignations.

The new website is now live. Work continues to bring in all required content and key phrases that will drive up Google rankings.

A couple of I.T. issues have been resolved and appropriate equipment investments have been made.

JS provided cashflow predictions that assumed no income other than memberships and same expenditure as previous year, plus removing NEC expenditure as show will not take place. Given these parameters, there will still be cash in the bank in 12 months' time.

IC held a virtual meeting with FEMA. Main concern is noise complaints from residents and attendant road closures. MAG to generate a position statement regarding motorcycles and noise.

MAG Media: it was noted that the last issue of The Road was much improved. New issue about to be distributed.

Board discussed Jon Strong's challenge regarding ABS and have requested a short (no longer than 3 pages) report to outline what he wants to achieve and what, if any, involvement there might be from MAG.

Board met with CB and LÖ regarding concerns relating to working with MCIA.

RRs to be requested to provide contact details in respect to local Wheels2Work franchises.

SW noted a disappointing response from the Scottish Government in respect to information provided regarding the role of motorcycles as part of the solution in coming out of lockdown.

Thames Valley: Pete Seymour

• Group Meetings: Although the Facebook groups are still running, alternative Zoom-type meetings have not all been so successful but have been held on a regular basis. Partly due to the technical challenges of hosting a meeting, or how to properly run an effective meeting online. There is also the challenge of how to widely communicate in advance of a meeting being held, and how to access it, passwords and such. Reading Group in particular has failed in this regard. Conversely, Wycombe Group have been more successful, a regular attendance number of 7-9, and found it helpful because wider spread members have been able to attend who normally physically cannot do so.

- Being a largely older and more suspicious/private cohort there are many MAG members who
  do not, or only infrequently, subscribe to the big surveillance society. Without a mailing list or
  other comms means, due to GDPR, we are losing touch with members and losing traction
  when we need it most.
- Curiously, as a good example of meetings and comms, Alcoholics Anonymous has thrived! Meeting lists are published, and members can, and do, Zoom all over the country.
- Both Reading Borough Council and Oxfordshire County Council are pressing ahead with radical transport plans, with additional walking/cycling road restrictions layered on at the specific request of Grant Shapps, Transport Minister.
  - I have been unable to effectively communicate with affected or influential groups, as I have been forced to do so via "sound bites" created & placed by Facebook Administrators.
- Reading Council tried to have an open on-line public consultation on their new Transport
  Strategy using Teams. It failed on both prior communication and technically on the day.
  Nobody in Reading MAG could access the meeting, despite live emails with the RBC
  administrators. RBC have now sent us a You Tube link to a recording of the meeting we were
  effectively excluded from.
  - The "consultation" covered transport charging options, e-scooters and bikes, temporary and permanent road restrictions, pollution reductions during lockdown, and an influential view on helmet and his-vis being worn by all 2-wheeler transport users. None of our prior written questions were answered then or afterwards.
- A followed-up referral from the NC, from the public about Oxford came up trumps!
  We only became aware of the RBC on-line consultation minutes before it went live. This was entirely due to this person letting me know he had found out about it. Not only that but he let me listen in by holding his own mobile phone to his pc until the meeting link went down.
- Wycombe Group are busy preparing for their Virtual Chinnor Rally, a 5hr Facebook event on the 4<sup>th</sup> July. Virtual tickets, virtual beer and real patches can be purchased by those attending. The patches will be designed and posted by their supplier and £1/patch given to the rally. Funds raised will again be split as previous years, between their local sponsors charities and MAG itself.
- Separately from this, Wycombe have utilised Thames valley MAG's relationship with Rebellion Brewery to obtain a % kickback for all beer sold via a specific web purchase link. Details being finalised now.

Motorcycle Live at Birmingham NEC has been cancelled which will save us a significant outlay.

#### Vice Chair:

It's been a very busy 2 months MAG wise, starting with the April Board meeting on Skype. I have spoken to a number of motorcycle trainers regarding the CBT issue. Whilst it has been a problem for some riders a few trainers have been using the lack of clear guidance from the DVSA and government to continue to provide CBT to those in need (as opposed to just those wanting it for leisure). As a result of these discussions I was contacted directly by the DVSA's Chief Driving Examiner who is the head of rider policy. He was interested not only in our concerns over CBTs but also the White Paper. As regards CBT more and more trainers are returning to work so the problems will ease but there remains an issue in respect to new riders wanting to do theory tests where shared use of computers is possibly an issue.

I have been helping (I hope) Colin and Lembit, by providing feedback on consultations, the white paper (and on-going developments) plus the multitude of PR documents that have gone out recently. I have encouraged three clubs to become supporters of Ride to Work Day (two of them national clubs). I have written another article for South East Biker and done a book review for Mr Mutch for The Road. I took part in the North Kent MAG Into the Garden Rally and the Tone Vale Virtual Tea Rally. Along with Selina and Alex we spent a morning trialling Microsoft Teams (a good hour of which was wasted by my own errors!). Following the lifting of some of the travel restrictions there were issues at a local beauty spot where bikers gather, the main issue being a concern over a lack of social distancing. As a result, I was interviewed by BBC Radio Lincolnshire. Plus, there's been all the usual national and local Facebook page admin and Board emails.

### **Updates**

**Offices** – Since my last report we are still under the same restrictions regarding COVID-19 and workplace arrangements. Carol has covered the office and ensured that memberships whether new or renewal are all up to date. I will cover any days that Carol may wish to take off so that there is always someone in the office until the restrictions reduce. PAT testing has been delayed by lockdown and will be checked as soon as possible after the restrictions have reduced/ended.

**IT** – As I write this we are at a point where the old website is about to be taken down. The new site is available now to be seen but not being picked up by Google until the old site has gone. We will then start to be able to see the analytics and have Google pointing to our site whatever the topic referencing to motorcycling. We are still to move over the historic data from the old site, but our priority was to get the site live and functioning. We have full access to the site and will be able to upload stories etc. from the office. We are still working on getting more hits to the site and are focused on wording so that our message is clear. Our first goal is to get more members, this is very clear on the new site and the messaging will

show this. All the information that you need access to when searching topics. This we may want to consider if it is a membership only benefit or not – we have it currently open for all, but we may want to give the headline and get a person interested and to see the full story you need to be a member to login to gain full access. It is an option for the future, but if we are successful in gaining more members, I personally feel full access to all would be the way to go. It's taken almost 10 years to get to this point, so I am very excited about this and I really do feel we have got the mix correct on the homepage. The content on the other pages will fill up as we proceed.

The Database is slowly moving forward Leslie has been extremely busy with work which is understandable with home working during lockdown and the needs of the university for lectures etc. This would form an upgrade and allow more accessibility to members with regards to opting in/out to which email lists that they prefer, then there is no confusion and the member has complete control which is better for us GDPR compliance wise. This will also be reflected with accessibility for RR's when wanting to see their current area members list or lapsed member list without coming through the office, which will make everyone's life much easier.

We have had a few email and email list issues. The email system went down due to a part of security certificate going out of date, this was not due to run out until September 2020. Andy M eventually sorted it out and then found that this was the case with several of the newer certificates, which he has now rectified. One of the email lists caused some grief for the North-East this week this has also been rectified as it had been set up as a discussion so all could respond without moderation, this has now been changed in line with the rest of the email lists. Only committee email lists will be set up as a discussion list and all member lists will have to go through moderation so that nothing can be released to all without the physical authorisation.

The office server had an issue completing back-ups, so the external back-up drives were replaced. This highlighted another issue when the latest software update was completed, and internal drives were failing so have had to be replaced. This was done immediately the issue was discovered so that there was no down time in the office.

Social Media training for Reps delayed due to Covid-19 this will be re-booked as soon as possible for a face to face event.

MAG Foundation – Advertising set up in the next edition of The ROAD. The Foundation AGM discussion has started and may be completed via an online conference.

Staff – Carol continues to work well on her own in the office. We speak daily and I see her once a week for a face to face so she can download. I have no concerns about her welfare working alone. Colin is extremely busy and has actually advised that he could not do everything (a first for Colin). Lembit is unable to meet with MP's but has been in contact with Keith Prince and managed to get some questions asked at Mayor's Question Time via Keith plus a few radio interviews. \*\*\*

\*\*\*

All staff have been asked to continue taking annual leave where possible, as we do not want a situation with travel restrictions only being reduced possibly in September or even later this year. As an organisation we would struggle should all employees wish to take leave at the same time. I have also stated that we may be able to take additional days over to next years' holiday entitlement with a caveat that the leave must be taken within the first three months or at least booked within that timeline. Nothing is set in stone but worth a heads-up as we are halfway through the year and only minimal days taken by everyone.

As lockdown happened without warning our accountants had not completely prepared for working from home. This caused an issue with reporting Pension contributions to SMART Pension, so they therefore have not collected the contributions. This has now been resolved and will be collected later this month.

The Employee Handbook continues to be under review, there are many changes with the outbreak of COVID-19 and April will see many changes come into effect that will require updating.

**Sub-Contractors contracts –** Mr M pro-active approach has continued into the current issue. Mr M has used his contact to proof this issue. Charley was advised that we needed to reduce costs where possible and has stepped aside during this period, this is to be reviewed once lockdown has ended.

My role – Things are running as smoothly as we are able to keep them. Finances are stable with minimal use of the reserves. To ensure cash flow is maintained I have delayed the VAT payment on NEL (we can pay this at any point in the future without fines up to 31<sup>st</sup> March 2021). MAG Media VAT has been paid as that was just over £200. TMAGL VAT is a repayment which will is due to be paid in the next week. I have renewed our Auto-Enrolment Pension declaration to ensure that we are fully compliant for another three years. We have the option to apply for a 'Bounce Back Loan' of up to £50k, this would ensure our cash flow is maintained as we have to prepare for not to receive donations from Stormin' (now confirmed postponed to Sept 2021) and the Yorkshire rallies. The loan would require pay back within a year without interest incurred. You will only start to pay interest after the year at a fixed rate of what is out standing on the loan and not the original loan amount. This is now worth considering for cash flow reasons only as I believe we are still in a good position financially. TMAGL AGM legal requirements as per our Articles of Association, I have not had a response to this from our accountants and will chase. I will collect the physical copy from the office and will be able to give a definitive answer in the next Board meeting.

Health & Safety – fixed wiring check due November 2020 has not been organised as yet but now there is a relaxation of lockdown, I will now be able to book. Looking at the office regarding return to work, we are already compliant, mainly due to only two members of staff working from the office. A few minor tweaks with regards to facilities and we will be ready to go.




### vii. Finance and membership figures

The Motorcycle Action Group Limited financial report up to end of May 2020.

Memberships taken by Bikesure via Go Compare/Quotezone comparison sites over the first 4.5 months of the year 138 new memberships and 159 renewals compared to 2019 for the same period we are 48 memberships down overall (total 2020 - 297: 2019 - 345). This has been caused by COVID-19 we have seen a reduction in new members taken but have seen an increase in renewals for the same period, which is positive.

The below graph shows that memberships by month have almost followed previous years patterns. May is currently sitting below all other years and still have standing orders and Bikesure memberships to add. Overall compared to 2019 the first part of the year is down a total of 74 memberships as shown in the Cumulative Memberships by Year graph below.







#### ii. Wheels2Work

W2W is a charity organisation that helps people with transport issues to access motorcycles/scooters to enable them to be able to attend job interviews and places of work. There is no nationally coordinated scheme. Regional organisations are set up on a basis that is similar to that of franchising. This is a scheme that is not currently widely recognised and there was some discussion around how to identify ways of raising the profile of this scheme, so that people realise it is for powered two wheelers, not cycles.

### **Resource Library**

Workload getting in the way again.

#### **Clean Air Zones**

Coronavirus continues to delay all implementation of these zones, though they will no doubt return to the agenda soon and there will inevitably be calls for them to be more draconian. The current COVID "emergency" situation is being used to push through road space reallocation that will have far more impact than CAZ's ever could, as there will simply be no-go zones created for motorised vehicles in most cities.

### **Crime/Secure Parking**

Still awaiting FOI response from Greater Manchester Police. This is a key response, but it is the only one holding up publication. I will take the decision following RTW Day whether to publish without them and make a big play of the lack of response from such a key area for motorcycle theft.

The sheer weight of other work meant that I was unable to complete a response to the Hackney parking consultation. Sadly, we have much larger threats and need to ensure there is a need for any motorcycle parking nationally at this point.

#### **MCIA**

Appeared on the Bennetts Torqueing Heads with Tony Campbell. Also pushed them to support our VED position, but that support will not be forthcoming.

#### **Road Safety**

Still little happening other than the continued use of road safety to justify not promoting motorcycles coupled with a complete unwillingness to invest in motorcycle safety.

The e-scooter trial is a clear demonstration that safety is an excuse not a reason when it comes to poor motorcycle policy. We need a breakthrough here.

### **ULEZ Campaign**

The return of ULEZ and the Congestion Charge is 180 degrees opposed to the Government line of promoting driving rather than public transport. There is a lot of smoke screening happening here however as the mandating and financing of pop up cycle lanes etc is very aggressive.

#### **Bus Lanes**

Nottingham have decided they could see no benefit from their bus lane trial and are to close the trial and remove motorcycle access. I am trying to engage with Nottingham City Council to reverse this daft decision based on no sensible evaluation.

### **Transport Policy**

Streetspace in London and the national mandate from Grant Shapps is rewriting the entire story for us. We need a plan and line of attack to crystallise very quickly. Emergency powers are being abused under the direction of the Secretary of State.

### **Ride to Work Day**

Ride To Work Day website launched 1<sup>st</sup> June. The campaign will now be intensely pushed in the shorter than planned lead up to the Day. Hoping to have the Filter Friendly video to launch on Ride To Work Day.

## ICE Ban/ Transport Decarbonisation Plan

Confirmation received that we are on the list of formal stakeholders. Awaiting news on engagement events. Motorcycle Carbon Emissions Paper to be published w/c 1<sup>st</sup> June.

As previously stated, the Government are using the COVID "emergency" to push this with the e-scooter trial advanced to precede the regulatory review process, mandating of road space re-allocation etc. The need to plan a meaningful response with a structured plan is vital. On the up-side pushing for electric motorcycles is being indicated as a relatively easy option with electrification pushed in every DfT response via ministers. A careful path needs to be tracked between defending ICE and promoting electric as a way to get motorcycling on the agenda.
